Detective tipped off suspects about child sex sting operation, Florida sheriff says

A Central Florida detective is accused of warning suspected child predators that they were targets of an undercover sting operation, the sheriff's office said.

Investigators began looking into the detective, assigned to the Crimes Against Children Unit, in April while the team was preparing for a sting operation to catch online predators, according to a news release from the Seminole County Sheriff's Office.

The undercover operation involved detectives posing as children online and messaging potential child predators.

Detectives made arrangements with the targets to meet up for sex, WESH reported, but then some targets suddenly stopped responding and didn't show up to the in-person meets.

Investigators went through team members' phones and traced messages warning the targets of the sting back to the detective's phone, WESH reported.

The detective sent messages to the targets saying, "She is fake dude, stay away," and "I'm trying to help you out, delete and go away," the outlet reported citing the sheriff's office.

The sheriff's office said the detective "covertly used technology to warn suspects intending to travel to meet minors for sex that they were involved in an undercover operation, allowing them to avoid arrest, and potentially putting other detectives in harm's way."

Only one of the five targets still showed up to the undercover meet, two others were caught later, and two have not been caught after receiving the detective's warning, WESH reported.

The sheriff's office did not release what may have prompted the detective to warn the suspects.

The detective, who joined the sheriff's office in 2010 and the child crimes unit in 2015, was suspended on April 21 as the investigation started, the sheriff's office said.

"You were responsible for protecting the most vulnerable members of our society, our children, and the actions you are alleged to have committed instead aided those who would seek to victimize children by allowing them to avoid arrest and prosecution," Sheriff Dennis Lemma said in the release.

On July 27, the detective was charged with 15 felony counts, including unlawful use of a two-way communication device, disclosure or use of confidential criminal justice information and unlawful use of a computer, network, or electronic device resulting in the interruption or impairment of governmental operation.

He was booked and placed on a \$65,000 bond, then given a GPS monitoring device, the sheriff's office said.

Lemma said the sheriff's office was in the process of terminating the detective's employment.

On July 28, the detective pleaded not guilty on all counts, WKMG reported.

The Seminole County Sheriff's Office is headquartered in Sanford, about 20 miles northeast of Orlando.

SYNOPSIS

In August of 2022, the Washington State Patrol's (WSP) Missing Exploited Children Task Force (MECTF), in partnership with several local and federal partners, conducted an online undercover (UC) operation in Grant County, Washington. On August 23, 2022, UC Det. Klein started chatting on a popular social media website called Skout as a 12-year-old minor female. The profile showed the age of 32 years old, and the name displayed was Crystal. UC Det. Klein was acting in an online undercover capacity as a 12-year-old female minor child.

DETAILS OF REPORT

On August 23, 2022, around 1230 hours, I received a direct message from a profile named "Deepimpact" that read, "What's up Crystal how are you doing today". For the full chats, see the Skout chats. They were brief and I told him to text my UC phone number (509-713-1805) with his username, so I knew it was him.

"Deepimpact" was later identified through law enforcement databases and open source intelligence as LEONARD, Joshua K. DOB 08/28/1977. A check through records showed LEONARD as a registered level 1 sex offender.

At approximately 1251 hours, I received a text message from the phone number 509-367-1804 that read, "Hey it's Josh you just gave me your number my screen name is Deep Impact 509" Below is a record of the messages between me in the UC capacity of a 12-year-old minor female and LEONARD. The chats labeled "Incoming" are from LEONARD and the chats labeled "Outgoing" are from me in the UC capacity of a 12-year-old female:

Throughout the conversation, LEONARD was well aware that I was 12 years old and even told me multiple times that there were creepy people online that I needed to be careful of. He stated we wanted the same thing and alluded to being with the UC 12-year-old female physically. During the course of the chats, LEONARD had multiple Google Duo calls with a UC officer. Google Duo is a video chatting platform. In one of the video chats, LEONARD told the UC 12-year-old female that he was going to bring her weed and spoke with her about cannabis. He said his penis was 7.5 inches long and wide. The UC said she did not want any diseases and LEONARD said he was clean. LEONARD said he was heading towards Moses Lake.

In the chats after that call, I asked LEONARD if he had condoms. He said of course he did, any man who is being careful and safe needed to have condoms. I asked if he was bringing them and he did not respond to that, instead started talking about his drive. I said I was scared it would hurt and he said that's where experience comes into play. I told him "R we gonna fuck or not? im getting confused" to which he replied that there was no need to be confused, think back on our conversation and I would know "what time it is" which I interpreted through our conversation and training and experience in working child exploitation cases to mean yes. He then asked to call again and conducted one last Google Duo phone call.

In the phone call, Leonard told the UC 12-year-old female, "The answer to your last question is yes." The UC asked if they were going to have sex and he shook his head yes. He then put his pinky up to the camera and pinky promised the UC 12-year-old that he would have sex with her.

He followed the UC's instructions to a pre-determined meet location in Moses Lake, WA. Once there, he agreed to go to the UC's residence to engage in sex acts there. Once at the residence, the UC officer stepped out on the front porch and spoke with LEONARD while he was seated in his vehicle. He then exited the vehicle and entered the UC residence. He was placed into custody without incident. It was clear that he went to the UC residence with the intention to engage in sex acts with who he thought to be a 12-year-old female minor.

A search incident to arrest revealed a cell phone on his persons along with a THC vape pen. I sent a test text to the cell phone, and it made a noise as if it had received a message but had no display. He was read his Constitutional Rights and agreed to be interviewed.

LEONARD had called the Moses Lake Police Department to report my profile online, saying he either thought it was a police sting or there was a real 12-year-old. I believe that this was in order to try to see if there was a UC operation going on to vet the UC 12-year-old. Once he was told there was no UC operation, he was more talkative in messages.

Prior to his arrest, it was discovered I had chatted with LEONARD in November of 2019 at a separate UC operation in Yakima, WA. In that operation, I was in the UC persona of a mother who was looking to have her 13 and 11-year-old daughters exploited. In those chats, LEONARD was on SKOUT under the name Jay. The pictures on his Skout account were of him. He used the phone number 509-676-6730 to communicate with me there. He said he had taken virginities before and will go slow and be gentle and patient with the 13 and 11-year-old minor children. He also said foreplay is very important. He then said it felt like a setup and he didn't want to go to prison.

LEONARD reported me to the police that operation as well in order to try to vet me and continued talking after he made the report. He eventually agreed to meet to engage in sex acts with the children but did not show up that time.

I declare under penalty of perjury under the law of Washington that the foregoing is true and correct.

It is anticipated that Operation Underground Railroad (OUR), will be submitting a donation of \$30,000 for operation Net Nanny 2. Net Nanny 1 was conducted in late August and concluded in early September with a focus on targeting sexual predators seeking sex with children in the Kitsap County area. During that operation, OUR donated nearly \$20,000 which was used to rent two apartments, fund overtime for the 15+ detectives assigned to the six-day operation. The results of which netted nine sexual predator arrests.

Net Nanny 2 will focus on those that traffic in the exploitation of minors in the Tacoma area. The donation of \$30,000 will be used specifically to cover all overtime costs associated with the operation including the collection and extraction of the digital forensics, court overtime, and lodging resources needed for the operation. Chief,

I've attached a brief synopsis of the arrests made during the Net Nanny 2 operation. In total, 10 physical arrests were made during the operational period (Tues, Dec 15 – Fri, Dec 18). Another convicted sex offender who corresponded during the operation should result in an additional arrest. In total, 11 arrests should result from Net Nanny 2 compared to the 9 arrests that were made during Net Nanny 1. This operation was a resounding success and I'm very proud of the MECTF coordination and execution of this operation.

Operation Underground Railroad (OUR) donated \$30k to fund Net Nanny 2. Not all \$30k was needed. Funds were used to; rent the house, purchase needed equipment for the operation

(printer), and fund hours of operation. OUR also provided food for all participants throughout the week. In the end, each suspect is facing Class A felony charges (multiple counts on some suspects) and the plea bargains start at 10 years in prison. Compared to other criminal cases that can take a year or longer, may result in a few years in prison, costs hundreds of man hours, and still only result in a single arrest, this is a significant return on investment. Mathematically, in only cost \$2500 per arrest during this operation! Considering the high level of potential offense, this is a meager investment that pays huge dividends.

We are already discussing future Net Nanny operations and planning for a minimum of 4 Net Nanny operations during 2016 around the state. Please let me know if you have any questions.

Sylvia,

I want to thank you for O.U.R.'s continued support of MECTF and helping us fight Child Exploitation. As you already know the next operation is nearing and I wanted to update you on a few things and also request another donation for our next operation.

First off I wanted to tell you one of our suspects committed suicide several weeks ago. IT is still under investigation by Lewis County and I am not at liberty to discuss the details of that case. I can tell you that even though our suspect is deceased in that case, we are still following up on other matters in that case in order to identify potential victims. Currently we are doing our best to identify children that our suspects had access to.

Net-Nanny 2:

You still have our donation letter, which discussing how we use our donations. This donation would be used to conduct a similar operation in Pierce County. Without our last donation our operation would not have been such a success. There is no way we could have been able to run the operation for such a long time and get the results that we did. For this next operation we are going to run for 4 to 5 days straight. We will have a similar focus with this operation. We will be focusing on suspects that are selling Code 3(a), offering to Code 3(a), and soliciting to have sex with children. We will also follow up on leads to identify children that are being used to manufacture child pornography.

I have also reached out to Parella Lewis form Q13's Washington's Most Wanted. She wants to cover the operation as well as speak with someone from OUR. She has worked with us in the past and does great job. Please send me the contact I need for your media section to set up time with Ms. Lewis.

The donation we received from OUR on the last operation was used for overtime hours during the operation. The donation did not cover all of the overtime costs. We also didn't plan for the additional overtime we would incur form all of the digital media we collected and the additional search warrants we had to write. We wrote 31 search warrants for the first Net-Nanny case. That is on top of our normal case load.

We spent \$17,500 of the last donation on overtime during the operation for 9 detectives, the remainder of the \$20,000 was spent on housing and undercover phones. To date we have spent 136 hours on the digital media alone. In overtime hours that would be equivalent to just over \$9,000

I am requesting an additional \$10,000 for a total of \$30,000 for the next operation. This amount should be sufficient to cover the overtime during and after the operation. This will also help us to process the digital media, search warrants, and any other tasks necessary to get the cases completed and to the prosecutor in a more timely manner. This will help us with our current caseload as well as planning our next Operation.

I used WSP wages for the costs listed above. <u>Unfortunately for WSP, our wages are significantly lower than other agencies in Washington State</u>. <u>That means the amounts listed above are much lower than the actual cost to run the mission since all participants are not WSP</u>. Even so, you can see we invest over \$100,000 in that 4 day period. These amounts do not include the hours spent before or after we are live at the trap house. We spend several weeks after we shut the operation down on follow-up, forensics, additional search warrants, etc.

The support you give us is used on the other costs and to support the WSP employees. This is the best way to make the donation last for a longer time since our wages are the lowest.

CHUN, J. — The State charged Brandon Pamon with attempted rape of a child in the second degree, attempted promotion of commercial sexual abuse of a minor, and communicating with a minor for immoral purposes. After a bench trial, the trial court found Pamon guilty as charged. It imposed an exceptional downward sentence. Pamon appeals, contending that his defense counsel was ineffective for failing to raise an entrapment defense and, in the alternative, that the court's findings do not support its determination that he took a substantial step toward the commission of attempted promotion of commercial sexual abuse of a minor. For the reasons below, we affirm.

I. BACKGROUND

A. Facts

In August 2018, Pamon received a Facebook "friend request" from a profile with the name Samantha "Sam" Collins. Undercover Washington State Patrol (WSP) Sergeant Carlos Rodriguez managed Sam's profile. Rodriguez used photos of WSP Trooper Jennifer Wilcox as photos of the fictitious Sam.

Some photos were edited with filters that made Wilcox appear younger. At the time, Rodriguez worked for the WSP Missing and Exploited Children's Task Force (MECTF), which conducts undercover operations—called "Net Nanny" operations—to identify sexual predators. Rodriguez testified that they targeted Pamon because, according to an FBI agent, Pamon had become Facebook friends with young girls.

Pamon accepted the friend request and messaged Sam, saying that he wanted to get to know her and that she was "hella gorgeous." Sam asked for Pamon's age, and he said that he was 20 years old; after Sam expressed disappointment that he could not buy alcohol, he responded with his correct age of 28. During their text exchange, he suggested that he "come and pick [her] up" and Sam told him she was 13 years old. Pamon responded by trying to video chat with Sam, which attempt Sam ignored. Pamon continued to try to video chat with Sam throughout their text exchanges. He told Sam he "want[ed]" her and that she was "hella sexy." A few days later, he asked Sam for a nude photograph and Sam sent him a photograph of Wilcox clothed. He told her he wanted to "f*** the s*** out" of her and mentioned sexual acts. During an exchange in which Sam alluded to her age by saying she thought her breasts would grow, Pamon responded, "How old are you and don't lie to me." She said, "I already told u. 13" to which he replied, "I know when I'm going to see you." Sam also mentioned that she "hustle[s] up in fed way sumtimes."

Communication between the two temporarily ceased in September and about three weeks later, in October, Sam initiated communication. During the

exchange, Pamon said, "You know what I want to do to you" to which she replied, "make paper lol" and "fr lmk." He responded, "Ya and I want to fuck you Hella bad." Throughout their exchanges, Sam alluded to sex work by calling Pamon "daddy," mentioning moving between multiple towns, and talking about "hustling" and "paper."

In December, Wilcox, pretending to be Sam, and Pamon spoke on the phone. During the call, Pamon suggested that he could "sell" Sam and make "good money." The two planned a meeting for December and Sam asked him to bring condoms. The meeting did not occur but the two continued to communicate. In later messages, Pamon asked Sam whether she was "ready to walk" and whether she would do "the track" for him—referencing the solicitation of sex customers on the street.

In January 2019, Pamon travelled by bus to meet Sam in Tacoma. While Pamon was travelling, Sam asked him, "u still wanna f*** me or just wanna make money or both?" and Pamon responded, "I want both." Sam gave him an address, and when Pamon arrived at the house, law enforcement arrested him. He was carrying a condom and the phone used to communicate with Sam.

B. Procedural History

The State charged Pamon with attempted rape of a child in the second degree, attempted promotion of commercial sexual abuse of a minor, and communication with a minor for immoral purposes. His case proceeded to a bench trial.

During Rodriguez's testimony, defense counsel moved to have the State disclose exculpatory evidence in the form of Sam's Facebook account. The State responded that defense counsel did not interview Rodriguez and did not request Sam's account before trial despite knowing the case involved Facebook. The State then pointed out that Pamon had not asserted the affirmative defense of entrapment. Defense counsel later moved to amend Pamon's defense to include entrapment, which motion the State opposed as untimely. The court requested briefing on the issue. After the parties rested, the court suggested they could address entrapment in their closing and the State objected. Defense counsel agreed to waive the entrapment defense, noting that he was "sufficiently pleased" with the way things turned out.

During trial, defense counsel contended that Pamon did not believe Sam's stated age and thus did not have the requisite intent for the three charged crimes. Defense counsel argued that Pamon's repeated attempts to video chat with Sam were attempts to verify her age. The defense emphasized Pamon's comment to Sam telling her not to lie to him about her age. The defense noted that the unedited photos of Sam on her Facebook profile appeared to be of a person older than 13 years of age and that some of her language and behavior was unusual for a 13-year-old. The defense contended that Pamon planned to see Sam in person to verify her age when he was arrested.

The trial court found Pamon guilty as charged.

During sentencing, the court noted that the degree to which law enforcement targeted Pamon here was unusual compared to typical MECTF "Net

Nanny" operations. The court found by a preponderance of the evidence three mitigating factors justifying an exceptional downward sentence. The first mitigating factor was that law enforcement, as the "complaining witness," was "to a significant degree, an initiator, willing participant, aggressor, or provoker of the incident." The second mitigating factor was that "the Defendant, with no apparent predisposition to do so was induced by others to participate in the crime" and the court found there was no evidence Pamon had been "friending young girls" on Facebook. And the third mitigating factor was that "the Defendant's capacity to appreciate the wrongfulness of his conduct, or to conform his conduct to the requirements of the law, was significantly impaired." The court found that Pamon "has a compromised intellect" and that Sam "initiated discussions of commercial sexual exploitation." The court sentenced Pamon to an indeterminate sentence of 96 months to life in prison.

The court entered the final judgment and sentence on March 27, 2020. Pamon appeals.

II. ANALYSIS

A. Ineffective Assistance of Counsel (IAC)²

Pamon says that his defense counsel provided ineffective assistance by failing to prepare, raise, and present an entrapment defense when the evidence

¹ Based on his criminal history, Pamon had an offender score of 9+, which led to a standard sentence range of 157.5–210 months to life in prison.

² The State contends that we must dismiss this appeal as untimely under RAP 5.2(a) because Pamon appealed his case more than 30 days after the entry of the final judgment and sentence. See State v. Molnar, 198 Wn.2d 500, 508, 497 P.3d 858 (2021) ("Generally speaking, a person seeking to challenge their conviction or sentence has 30 days in which to initiate a direct appeal."). But a Division Two Commissioner

justified such a defense. The State contends that defense counsel pursued the most viable defense and that Pamon cannot establish prejudice. We conclude defense counsel did not perform deficiently.

We review de novo IAC claims. <u>State v. Feely</u>, 192 Wn. App. 751, 768, 368 P.3d 514 (2016). The Sixth Amendment to the United States Constitution and article I, section 22 of the Washington Constitution guarantee the right to effective assistance of counsel. <u>State v. Vazquez</u>, 198 Wn.2d 239, 247, 494 P.3d 424 (2021). "Courts indulge a strong presumption that the counsel is effective." <u>Id.</u>

"To demonstrate ineffective assistance of counsel, a defendant must make two showings: (1) defense counsel's representation was deficient, i.e., it fell below an objective standard of reasonableness based on consideration of all the circumstances; and (2) defense counsel's deficient representation prejudiced the defendant, i.e., there is a reasonable probability that, except for counsel's unprofessional errors, the result of the proceeding would have been different."

Id. at 247–48 (quoting State v. McFarland, 127 Wn.2d 322, 334–35, 899 P.2d 1251 (1995)). The defendant bears the burden of establishing that defense counsel's performance was deficient by showing "the absence of legitimate strategic or tactical reasons supporting the challenged conduct by counsel." Id. at 248 (quoting McFarland, 127 Wn.2d at 336). "[W]e are highly deferential to the performance of counsel." State v. Crawford, 159 Wn.2d 86, 98, 147 P.3d 1288 (2006). "A reasonable probability is a probability sufficient to undermine

addressed the issue and found grounds to extend the deadline for filing the notice of appeal and accepted it as timely. RAP 18.8 permits this, and we decline to dismiss the appeal on this basis.

confidence in the outcome." <u>Vazquez</u>, 198 Wn.2d at 248 (quoting <u>Strickland v. Washington</u>, 466 U.S. 668, 694, 104 S. Ct. 2052, 80 L. Ed. 2d 674 (1984)).

RCW 9A.16.070 defines the entrapment defense as such:

- (1) In any prosecution for a crime, it is a defense that:
- (a) The criminal design originated in the mind of law enforcement officials, or any person acting under their direction, and
- (b) The actor was lured or induced to commit a crime which the actor had not otherwise intended to commit.
- (2) The defense of entrapment is not established by a showing only that law enforcement officials merely afforded the actor an opportunity to commit a crime.

The use of a "normal amount of persuasion" by law enforcement does not suffice for the defense. State v. Trujillo, 75 Wn. App. 913, 918, 883 P.2d 329 (1994). The State can use a variety of evidence to prove intent, such as ready compliance with an illegal request, demonstrated eagerness to commit the crime, and substantial effort in investigating and arranging an illegal transaction. State v. Pleasant, 38 Wn. App. 78, 81, 684 P.2d 761 (1984); State v. Enriquez, 45 Wn. App. 580, 586, 725 P.2d 1384 (1986); Trujillo, 75 Wn. App. at 919. "[M]ere reluctance" to violate the law does not suffice to establish a lack of intent to commit the crime. Trujillo, 75 Wn. App. at 918. A defendant must prove entrapment by a preponderance of the evidence. State v. Lively, 130 Wn.2d 1, 13, 921 P.2d 1035 (1996).

Declining to present a defense that is unlikely to succeed³ is a legitimate

³ The State discusses this argument as a reason why Pamon fails to establish prejudice rather than a reason why defense counsel was not deficient. While we see how it relates to both elements of the IAC standard, we feel it is best addressed here. See State v. Classen, 4 Wn. App. 2d 520, 539, 422 P.3d 489 (2018) (holding that defense counsel was not deficient for not presenting a voluntary intoxication defense where one was unsupported by the evidence).

strategic choice.⁴ See Vazquez, 198 Wn.2d at 248 (noting that counsel is deficient if the record lacks a legitimate strategic reason for counsel's conduct). And the entrapment defense was unlikely to succeed in this case. The second question in the entrapment analysis is whether Pamon lacked the intent to commit the charged crimes, and it appears he did not. Sam did target Pamon by sending him a friend request, unlike typical MECTF operations that involve putting out an ad for sexual encounters. But his eager and willing response to the opportunity to have sex with a 13-year-old, strongly suggests intent as to the rape charge. After Sam told him she was 13 years old, he made multiple sexual comments, including saying she was "hella sexy," saying that he "want[ed]" her, saying that he wanted to "f*** the s*** out of" her, and asking her for nude photographs. See State v. Pouncy, No. 54670-1-II, slip op. at 19 (Wash. Ct. App. Nov. 30, 2021) (unpublished), https://www.courts.wa.gov/opinions/pdf/

⁴ Pamon says that the State mischaracterizes his counsel's decision not to raise the entrapment defense as a strategic choice, and that the lack of an entrapment defense was instead the "inescapable result" of defense counsel's failure to adequately investigate evidence before trial. Pamon contends that, had defense counsel performed an adequate investigation, counsel would have discovered the evidence Pamon contends supports an entrapment defense before trial, rather than during trial, allowing counsel to timely raise the defense. But this argument focuses on the subjective reason behind counsel's decision not to raise an entrapment defense. Pamon cites no authority saying that the subjective reason behind defense counsel's challenged behavior matters for our analysis. Instead, we review counsel's decision not to raise entrapment based on an "objective standard of reasonableness." <u>Vazquez</u>, 198 Wn.2d at 247-48 (quoting McFarland, 127 Wn.2d at 334-35). If Pamon contends that his defense counsel's failure to investigate was objectively unreasonable, he fails to show such a failure prejudiced him, because we conclude that the evidence defense counsel eventually discovered during trial is unlikely to support a viable entrapment defense. See Vazquez, 198 Wn.2d at 247-48. So even if defense counsel had discovered the evidence before trial, it was unlikely to have affected the outcome.

law enforcement officers induced Pouncy to respond to the 'Alexis' profile or continue communicating with 'Alexis' after he learned she was only 13 years old"). These facts also support intent as to the communication with a minor charge. And Pamon travelled to meet Sam and arrived with a condom. See State v. Carson, No. 36057-1-III, slip op. at 9–10 (Wash. Ct. App. Oct. 2, 2018) (unpublished), https://www.courts.wa.gov/ opinions/ pdf/360571_unp.pdf.6 (holding that the defendant was not entitled to an entrapment defense where he travelled to meet the child and "showed his persistence by following the mother's directions to first drive to a gas station before the mother would provide the home address" and arrived with condoms). Pamon emphasizes that after a three-week period of no communication, Sam, not Pamon, was the one to reach back out. But he showed no reluctance to continue communicating with her and make plans to see her.

As for the attempted promotion charge, Pamon contends that his lack of response to Sam's initial comments about "hustl[ing]" shows a lack of intent to commit the crime. But after Sam raised the topic multiple times, he engaged and told her he could "sell" her and "make good money" and asked her whether she would do "the track" and was "ready to walk." See Pleasant, 38 Wn. App. at 81 (noting the "defendant's extensive knowledge of the customs and usages of the drug trade" in assessing predisposition); Enriquez, 45 Wn. App. at 586 (holding that the defendant "failed as a matter of law to make out a defense of

⁵ <u>See</u> GR 14.1(c) ("Washington appellate courts should not, unless necessary for a reasoned decision, cite or discuss unpublished opinions in their opinions.").

⁶ See GR 14.1(c).

entrapment" where he eventually agreed to sell narcotics after an "informant repeatedly" suggested that he do so). Moreover, "mere reluctance" to violate the law does not suffice to conclude that Pamon lacked criminal intent. See Trujillo, 75 Wn. App. at 918. Because the entrapment defense was unlikely to succeed, Pamon's defense counsel was not deficient in failing to prepare, raise, and present it.⁷

The State's main argument on why defense counsel's performance was not deficient is that his defense theory—that Pamon lacked intent because he did not believe Sam's stated age—conflicted with the entrapment defense. Thus, the State concludes, it was a legitimate strategic choice to assert the defense it did instead of entrapment. But Pamon points out that this reasoning was rejected in State v. Arbogast, in which the court said that, while the entrapment defense conflicts with a defense that denies criminal conduct, it does not conflict with a defense that denies criminal intent. 15 Wn. App. 2d 851, 870, 478 P.3d 115 (2020), review granted, 197 Wn.2d 1007, 484 P.3d 1262 (2021).8

⁷ On appeal, the parties dispute Pamon's burden of proof to show the elements of entrapment. The State contends it is preponderance of the evidence and Pamon contends that he need only show prima facie evidence. In so arguing, the parties cite authorities that address the burden of proof in the context of assessing whether a court erred by refusing to give a jury instruction on entrapment. But the question here is whether such a defense was likely to succeed, not whether the court erred by refusing to give jury instructions. To prevail on an entrapment defense, Pamon bears the burden of proving it by a preponderance of the evidence. <u>See Lively</u>, 130 Wn.2d at 13.

⁸ <u>But see State v. Forler</u>, No. 79079-0-I, slip op. at 13 (Wash. Ct. App. June 10, 2019) (unpublished), https://www.courts.wa.gov/opinions/pdf/790790.pdf (holding that the defense theory that the defendant lacked the requisite mens rea for attempted rape of a child and attempted commercial abuse of a child conflicted with an entrapment defense and that defense counsel was not deficient for choosing to pursue that defense theory instead of an entrapment defense); <u>see</u> GR 14.1(c).

Finally, Pamon contends that the fact that the trial court found by a preponderance of the evidence the mitigating factors that (1) law enforcement was "to a significant degree, an initiator, willing participant, aggressor, or provoker of the incident" and (2) "the Defendant, with no apparent predisposition to do so was induced by others to participate in the crime," shows that the evidence supports the entrapment defense. But he cites no authority suggesting that we can look to a court's findings on mitigating sentencing factors when assessing the viability of an affirmative defense. To the contrary, it appears we should not consider the court's mitigating factor findings in assessing this issue. Cf. Lively, 130 Wn.2d at 16 (in the context of entrapment, stating, "This court will not conclude, however, that mitigating factors used to justify an exceptional sentence may be considered in evaluating whether there was sufficient evidence to submit an issue to a jury"); see also State v. Jeannotte, 133 Wn.2d 847, 852, 947 P.2d 1192 (1997) (referring to the lack of apparent predisposition mitigating factor as "failed entrapment"). Before closing, the court suggested such a defense may not be viable after reviewing entrapment case law saying, "And candidly, I think at this point there are some difficult issues, legal issues, that may obviate the need for oral argument about entrapment or not." And its comments at sentencing and its sentence of 96 months to life suggest a belief in Pamon's quilt.

Because we conclude defense counsel's performance was not deficient, we decline to reverse Pamon's convictions on IAC grounds.

B. Substantial Step

Pamon says the trial court's findings of fact do not support its determination that he took a substantial step toward committing the crime of attempted promotion of commercial sexual abuse of a minor. The State responds that substantial evidence supports the findings because Pamon asked Sam about "walk[ing]" for him, referenced "the track," and travelled to meet her. Pamon says that the court's "finding" that he took a substantial step is not a finding but a conclusion of law and that his sole contention is that the court's findings do not support it. We conclude that the court's findings support a determination that Pamon took a substantial step toward committing the crime of attempted promotion of commercial sexual abuse of a minor.

Following a bench trial, we limit our review to "whether substantial evidence supports the trial court's findings and whether the findings support its

⁹ Pamon assigns error to the portion of finding of fact 10 discussing the "substantial step" requirement and says the court mislabeled it. Pamon cites Department of Labor & Industries v. Lyons Enterprises, Inc., to argue that we should treat the finding as a conclusion and review it accordingly. 186 Wn. App. 518, 529–30, 347 P.3d 464 (2015), aff'd, 185 Wn.2d 721, 374 P.3d 1097 (2016) ("[I]f a conclusion of law is labeled as a finding of fact, then it will be treated as a conclusion of law and reviewed de novo."). But Washington courts have long held that whether conduct constitutes a substantial step is a question of fact. See, e.g., State v. Workman, 90 Wn.2d 443, 449, 584 P.2d 382 (1978) ("The question of what constitutes a 'substantial step' under the particular facts of the case is clearly for the trier of fact."); State v. Billups, 62 Wn. App. 122, 126, 813 P.2d 149 (1991) ("Whether conduct constitutes a 'substantial step' toward the commission of a crime is a question of fact."); State v. Wilson, 158 Wn. App. 305, 317, 242 P.3d 19 (2010) ("Whether conduct constitutes a substantial step is a question of fact."). Even if a determination that Pamon took a substantial step toward the commission of the crime is a conclusion of law, as reflected below, the court's findings support such a conclusion.

conclusions of law." In re Dependency of Schermer, 161 Wn.2d 927, 940, 169 P.3d 452 (2007).

"A person is guilty of an attempt to commit a crime if, with intent to commit a specific crime, he or she does any act which is a substantial step toward the commission of that crime." RCW 9A.28.020(1). "Attempt consists of two elements: (1) intent, and (2) a substantial step." State v. Wilson, 1 Wn. App. 2d 73, 83, 404 P.3d 76 (2017). "The intent required is the intent to accomplish the criminal result of the base crime." State v. Johnson, 173 Wn.2d 895, 899, 270 P.3d 591 (2012). "We look to the definition of the base crime for the requisite criminal result." Id. "A substantial step is an act that is 'strongly corroborative' of the actor's criminal purpose." Id. (quoting State v. Luther, 157 Wn.2d 63, 78, 134 P.3d 205 (2006)). "Mere preparation to commit a crime is not an attempt."

Wilson, 1 Wn. App. 2d at 83. "But '[a]ny slight act done in furtherance of a crime constitutes an attempt if it clearly shows the design of the individual to commit the crime." Id. (alteration in original) (quoting State v. Price, 103 Wn. App. 845, 852, 14 P.3d 841 (2000)).

"A person is guilty of promoting commercial sexual abuse of a minor if he or she knowingly advances commercial sexual abuse or a sexually explicit act of a minor or profits from a minor engaged in sexual conduct or a sexually explicit act." RCW 9.68A.101(1). A person "advances commercial sexual abuse of a minor" when they engage in any conduct "designed to institute, aid, cause, assist, or facilitate an act or enterprise of commercial sexual abuse of a minor." RCW 9.68A.101(3)(a).

After trial, the court found that Sam and Pamon "discussed Sam working as a prostitute for [Pamon]." The court found that Pamon told Sam on the phone "I can sell you, make me some good money" and that it was "clear from the context of the telephone conversations that [Pamon] and Sam were talking about having sex together and Sam having sex with others to make [Pamon] money." It also said, "Based on the hundreds of text messages, and the telephone calls, the court finds the overall context of the communication is that Sam would both engage in acts of sexual intercourse with [Pamon] and earn money for [Pamon] by engaging in acts of commercial sexual acts or prostitution." Finally, it found that Pamon travelled to an address Sam provided while communicating with Sam "about sexual matters" and was arrested with a condom. The court determined that Pamon was guilty of attempted promotion of commercial sexual abuse of a minor because Pamon, with the intent to commit the base crime, took a substantial step toward commission of the crime.

Pamon distinguishes his case from two Washington cases about attempted promotion of commercial sexual abuse of a minor. In <u>Johnson</u>, the defendant asked undercover officers posing as minors if they wanted to work for him as a "ho," explained what a "ho" does, told them what type of customer to seek, and instructed them to give earnings to him. 173 Wn.2d at 900. Johnson also tried to arrange training by "one of his experienced girls." <u>Id.</u> The court held that "a rational trier-of-fact could conclude beyond a reasonable doubt that

women who claimed to be 17 years old and that he took a substantial step in that direction." <u>Id.</u>

Pamon says that, unlike in <u>Johnson</u>, he did not make any particular plan with Sam for how, when, or where she should perform sex work or how much she should charge. He contends without such actions, simply discussing the idea with Sam and travelling to her location did not constitute a substantial step. But <u>Johnson</u> does not purport to establish a floor for what actions constitute a substantial step toward the commission of attempted promotion of commercial sexual abuse of a minor. The court's findings support its determination that Pamon took such a substantial step. That he travelled to meet with Sam, taken in the context that he and Sam repeatedly "discussed Sam working as a prostitute"—making comments such as "I can sell you, make me some good money"—is "strongly corroborative" of his criminal intent. <u>Johnson</u>, 173 Wn.2d at 899; <u>see also Wilson</u>, 1 Wn. App. 2d at 85 (considering the "context of the relationship and the circumstances" in assessing a substantial step for an attempt crime).

We affirm.





Definitions of Terms

Applicability of Terms

Although some of the definitions below may be generally applicable to law enforcement, they are intended for use in the interpretation of these *Standards*. As such, where any term defined below is capitalized in these *Standards*, the *Standards* are referring to that term as defined below. By contrast, where any term defined below is not capitalized in these *Standards*, the *Standards* are referring to that term as it is used generally in the field of law enforcement. Additionally, the capitalized terms have been italicized to ease their recognition.

- "Affiliate" or Affiliate Agency" is an agency that is working with a *Lead Agency* as part of a regional or state ICAC *Task Force*. An *Affiliate* has agreed in writing to adhere to these *Standards*.
- "Authorized Personnel" are *Members* who themselves lack powers of arrest but have been authorized by their respective agency to participate in *Investigations* and are being supervised by *Sworn Personnel*.
- "Commander" is the *Member* of a *Lead Agency* who has been designated by that *Lead Agency* and recognized by *OJJDP* as the leader of the corresponding *Task Force*.
- "CEOS" is the Child Exploitation and Obscenity Section of the Criminal Division of the Department of Justice.
- "Contraband Image" is a visual depiction in any form (including printed/digital or video) of child sexual exploitation as defined by federal and/or state statute.
- "Crime" is any offense (or group thereof) that involves (or involve) the exploitation/victimization of children facilitated by technology.
- "CVIP" is the Child Victim Identification Project operated by NCMEC.
- "CyberTipline" is a reporting mechanism operated by NCMEC that allows for the reporting of suspected *Crimes*.
- "**Deconfliction**" is a process whereby *Members* are able to submit *Investigative* information to each other and/or to ICAC-related databases in order to determine whether other *Members* or other law enforcement agencies have information concerning the same targets or *Crimes*.
- "DOJ" is the United States Department of Justice.
- "Employee" is a sworn or compensated individual, or any individual working under the direction and control of a law enforcement agency.

- "Equipment" is any article, device or resource, including but not limited to computers, phones, online accounts and internet services which are purchased or obtained for use in ICAC-related matters.
- "ICAC Program" is the Internet Crimes Against Children Task Force Program, a national program composed of state and regional *Task Forces* administered by *OJJDP*.
- "Investigation" is an investigation into a *Crime*. Likewise, "Investigate" "Investigating" and "Investigative" are used within the same context.
- "Investigative Persona" any identity established or created by an *Employee* to aid an *Investigation*.
- "Investigator" is a *Member* who is a part of the *Sworn Personnel* of a *Task Force*.
- "Lead" or "Lead Agency" is the law enforcement agency that receives the ICAC grant and is designated by OJJDP to act as the Lead Agency for the corresponding Task Force.
- "Member" is a *Lead* or *Affiliate Agency's Employee* who is either *Sworn Personnel* or *Authorized Personnel* and who has been designated to work on ICAC-related matters for his/her respective agency and *Task Force*.
- "National Initiative" is any proposal that relies on the cooperation and resources of a significant number of *Task Forces* and, accordingly, has been approved by *OJJDP*.
- "NCMEC" is the National Center for Missing and Exploited Children.
- "OJJDP" is the Office of Juvenile Justice and Delinquency Prevention within the *DOJ*.
- "Supervisor" is a *Member* who has been designated by his/her respective agency to supervise *Investigations* and other ICAC-related matters.
- "Standards" are all of the provisions of these, the ICAC Operational and Investigative Standards.
- "Sworn Personnel" are *Members* with powers of arrest.
- "Task Force" is the *Lead Agency* and their *Affiliate(s)* (combined) as designated by *OJJDP* for a particular state or region.

1. Purpose of the ICAC Standards

These *Standards* are established by *OJJDP* to guide the administration and operation of the *ICAC Program* and its *Members* when working on ICAC-related *Investigations* and matters.

Members should make every reasonable effort to comply with these *Standards*. However, since many aspects of *Investigations* are dynamic and because laws vary widely between jurisdictions, it is difficult to anticipate every circumstance that might present itself. Thus, reasonable deviations from these *Standards* may occur depending upon various factors (e.g., emergency situations; timing constraints; accessibility constraints; resource constraints; technology constraints; perceived conflicts between the *Standards* and statutes, decisional law, and court orders; etcetera).

Commanders may supplement, but not contradict, these Standards in the written agreements they establish with their Affiliates to promote the effective operation of their Task Forces. Should questions regarding the interpretation of these Standards arise or conflicts occur between these Standards and agency policies or law, the Commander faced with the issue shall seek the guidance of an OJJDP Program Manager. However, nothing in these Standards is meant to interfere with a Commander's or Supervisor's lawful tactical decision-making.

2. ICAC National Program

2.1 Mission of the ICAC Program

The Internet Crimes Against Children (ICAC) Task Force Program helps state and local law enforcement agencies develop an effective response to technology-facilitated child sexual exploitation and internet crimes against children. This support encompasses forensic and *Investigative* components, training and technical assistance, victim services, prevention and community education.

2.2 ICAC Background

The Internet Crimes Against Children (ICAC) Task Force Program was developed in 1998 in response to the increasing number of children and teenagers using the internet and other technology, the proliferation of child sexual abuse images available electronically, and the heightened online activity by predators seeking unsupervised contact with potential underage victims.

The *ICAC Program* is a national network of 61 coordinated task forces representing more than 4,500 federal, state, and local law enforcement and prosecutorial agencies. These agencies are engaged in both proactive and reactive investigations, forensic examinations, and criminal prosecutions. By helping state and local agencies develop effective, sustainable responses to online child victimization – including responses to child sexual abuse images (*Contraband Images*), the *ICAC Program* has increased law enforcement's capacity to combat technology-facilitated crimes against children at every level.

Because arrests alone cannot resolve the problem of technology-facilitated child sexual exploitation, the *ICAC Program* is also dedicated to training law enforcement personnel, prosecutors and other professionals working in the ICAC field, as well as educating parents, youth, and the community about the potential dangers of online activity including online child victimization.

3. Oversight of the ICAC Program

- 3.1 The oversight of the *ICAC Program* and the administration of ICAC grants are the responsibility of *OJJDP*. The oversight of each *Task Force* falls to its *Commander*. The oversight of each agency, both *Lead* and *Affiliate*, falls to its designated *Supervisor*.
- 3.2 *Commanders* shall ensure there are supervisory systems and protocols in place that provide for observation, documentation, and review of ICAC activity. Said systems shall comply with the principles of quality case management and shall ensure that ICAC activities comply with agency policies and these *Standards*.
- 3.3 Commanders shall ensure that each Member in his/her Lead Agency and each Supervisor of an Affiliate Agency receives a copy of the Standards.
 - 3.3.1 *Supervisors* shall have the discretion to provide *Members* with only the sections of the *Standards* applicable to their job functions.
- 3.4 *Commanders* shall submit all proposed *National Initiatives* to *OJJDP* prior to the start of the project.
 - 3.4.1 *OJJDP* may suggest amendments to the original proposal following consultation with the presenting *Commander* and, as appropriate, other federal, state, and local entities.
- 3.5 Supervisors shall inform their Members about departmental employee assistance programs and Task Force resources available to them.

4. Selection and Retention of Task Force Members

- 4.1 When practicable during the selection process of *Members, Commanders* and *Supervisors* shall evaluate prospective candidates for work histories that indicate prior *Investigative* experience, courtroom testimony skills, technical knowledge and ability, an ability to prudently handle sensitive information, a genuine interest in the protection of children, and an understanding of the effects that *Members* may experience when exposed to *Contraband Images*.
- 4.2 Commanders and Supervisors shall acknowledge the potential effects of Investigations of and exposure to Contraband Images and recognize that the viewing of Contraband Images should be restricted. When practicable, the following techniques may help mitigate some of the potential negative effects of this work may aid with the retention of Members:
 - Work flexibility Commanders and Supervisors are encouraged to allow flexibility for Investigators and others who are exposed to Contraband Images (e.g., frequent breaks, having an open-door policy, etc.).
 - Exposure to *Contraband Images Commanders* and *Supervisors* are encouraged to implement best practices which minimize the exposure to *Contraband Images* by *Members*.
 - Mental Health Providers (MHP) In compliance with their agency guidelines, *Commanders* and *Supervisors* are encouraged to work with MHP to make recommendations for care of *Members* and to provide education and training designed to minimize the impact of exposure to *Contraband Images*.
 - Impact of Contraband Images Commanders and Supervisors are encouraged to share or pursue best practices for minimization of the impact of Contraband Images and to promote attendance at trainings regarding methods used to minimize said impact.
- 4.3 Commanders and Supervisors shall recognize that ICAC Investigations typically focus on child sex offenders who have committed serious state or federal crimes and due to this life-changing event, the impact on these offenders can result in a violent response to authorities.¹

5. Training

Ensuring that personnel are well-trained in conducting effective *Investigations* in a manner consistent with applicable laws is integral to the *ICAC Program*.

- 5.1 All national training curricula supported by *ICAC Program* resources shall be conducted consistent with the *Standards* and shall be approved by *OJJDP*.
- 5.2 Commanders shall ensure that nominees to attend any *ICAC Program*-sponsored national <u>in-person</u> training event are current *Members*.
- 5.3 Individual *Task Forces* may develop and deliver *Task Force* specific training. This training shall comply with the *Standards* and shall be approved by the *Commander*. All costs to develop and deliver the training shall be the responsibility of the *Task Force* or *Affiliate* providing the training.

6. Case Management

- 6.1 Commanders and Supervisors are responsible for determining Investigative priorities and selecting cases for Investigation in their respective agencies. Those determinations shall include an assessment of victim risk, jurisdiction, known offender behavioral characteristics, and the likelihood of securing the information necessary to pursue each Investigation.
- 6.2 Conventional boundaries often are meaningless in today's digital world where the usual constraints of time, place, and distance lose their relevance. These factors increase the possibility of *Lead* and/or *Affiliate Agencies* targeting other law enforcement personnel, *Investigating* the same target, or inadvertently disrupting an ongoing *Investigation*. To foster effective case coordination, collaboration, and communication, each *Member* shall make every effort to *Deconflict* all active *Investigations*.
- 6.3 Lead and Affiliate Agencies shall be subject to their respective agency's incident reporting procedures and case supervision systems. At a minimum, a unique identifier shall be assigned to each case.

7. Task Force Reporting Requirements to OJJDP

- 7.1 The reports described below do not replace the semi-annual progress report required by the Office of Justice Programs' Financial Guide.
- 7.2 *Commanders* shall compile and submit a Task Force Monthly Performance Measures Report to the *OJJDP*-designated location before the end of the following calendar month.
 - 7.2.1 Affiliates shall report their activity to their respective Commander by the 10th of each month using the ICAC Monthly Performance Measures Report.
- 7.3 *Commanders* shall compile and submit an annual report which details each of their *Affiliates*. This annual report shall be submitted within 30 days of the end of the calendar year. The report shall be submitted in a method determined by *OJJDP* and shall include the following information:
 - 7.3.1 The name of each *Affiliate Agency*.
 - 7.3.2 The staffing level of each *Affiliate Agency* including the number of *Investigators*, prosecutors, education specialists, and forensic specialists dedicated to *Investigating* and prosecuting *Crime*.

8. Investigations

- 8.1 *Investigations* shall be conducted in a manner consistent with applicable laws and the ICAC *Standards*.
- 8.2 Only *Sworn Personnel* shall conduct *Investigations*.
 - 8.2.1 Authorized Personnel acting under the direction and supervision of Sworn Personnel may participate in Investigations.
 - 8.2.2 *Members* shall not approve, condone, encourage, or promote cybervigilantism by private citizens. As such, *Members* shall not use unauthorized private citizens to proactively seek out *Investigative* targets.
 - 8.2.3 The above section (8.2.2) shall not preclude the use of information related to a *Crime* provided by victims or public citizens who discover evidence (e.g., CyberTip reports, mandated reports from professionals, computer repair shop complaints, parental complaints, et cetera). Nor does it preclude the use of authorized over-hears or other similar *Investigative* methods designed to further an *Investigation*.
- 8.3 *Investigations* shall be documented. Any departures from this provision due to unusual or exigent circumstances shall be documented in the relevant case file and reviewed by the *Supervisor*.
 - 8.3.1 The access, retention, storage, security, and disposal of *Investigative* or case information shall be consistent with the subject agency's policies and federal and state law regarding same.
- 8.4 *Members* shall not electronically upload, transmit, or forward any *Contraband Images*.
 - 8.4.1 Exception to Section 8.4. Section 8.4 shall not prohibit the transfer of evidence between *Investigators* as provided for by sections 8.9 and 8.10 of these *Standards* nor does it prohibit the submission of *Contraband Images* to CVIP as provided for by section 10.1 of these *Standards*.
- 8.5 *Members* shall not use any visual depiction of any type (including a manipulated or electronically generated visual depiction) of any person, purported person, or body part of a person or purported person, with the sole exception that a *Member* may use a visual depiction as a representation of an *Investigative Persona*/person/purported person when the following **four** requirements are met:
 - (1) The visual depiction is of an actual person;
 - (2) That person is an *Employee*;

- (3) The *Employee* has given his or her written consent for the visual depiction to be used; and
- (4) The *Employee* was at least 18 years old at the time when the *Employee* gave consent for such use. The visual depiction may be of the *Employee* that was produced when the *Employee* was under the age of 18. The visual depiction may also be modified to suit *Investigative* needs (*i.e.*, it may be an altered or age-regressed visual depiction of the *Employee*).
- 8.5.1 Exception to Section 8.5. Section 8.5 does not prohibit a federal or federally-approved *Member* (e.g., an FBI/HSI agent, or an FBI/HSI Task Force Officer) from using a visual depiction that does not meet the four requirements of Section 8.5, so long as the visual depiction is one that has been authorized for use by the FBI or HSI in accordance with that respective federal agency's guidelines and the visual depiction is being used pursuant to those guidelines.
- 8.6 Absent prosecutorial input to the contrary, during online dialogue, *Investigators* shall allow the *Investigative* target to set the tone, pace, and subject matter of the online conversation.
 - 8.6.1 Section (8.6) shall not be construed to prohibit *Investigators* from performing any of the following activities when initiating or conducting an *Investigation*: (a) posting information including visual depictions (image or video/printed or digital) to establish an online presence, (b) placing or posting advertisements, or (c) sending messages.
 - 8.6.2 *Members* shall familiarize themselves with relevant state and federal law, including but not limited to those regarding the defense of entrapment, and shall confer with prosecutors, as needed.
 - 8.6.3 Prior to conducting any large-scale (multi-target) operations, *Members* shall notify the *Commander* and shall consult relevant prosecutors about the operation.
- 8.7 The examination of digital storage devices shall be performed consistent with the subject agency's protocol.
- 8.8 Contraband Images shall be maintained pursuant to the subject agency's policy.
 - 8.8.1 Absent a court order specifically ordering otherwise, evidence containing *Contraband Images* shall not be released to any defendant or representative thereof.

- 8.9 Absent exigent circumstances, all *Members*' case referrals between *Task Forces* shall include:
 - Notification to and acceptance by the *Commander(s)* of both *Task Forces* that are involved in the referral;
 - A secure (i.e., digitally-protected) copy of the case file;
 - An official *Investigative* report or affidavit containing case details; and,
 - Documentation, preferably the original, of all legal process conducted and all compliance with same, especially those documents related to the issue of jurisdiction and identification of suspect(s).
- 8.10 Law enforcement transfers of evidence containing *Contraband Images* shall be done in a secure manner.

9. Work Environment and Equipment

- 9.1 *Investigations* shall be conducted in an approved work environment, using approved *Equipment*, as designated by a *Commander* or *Supervisor*.
- 9.2 *Commanders* and *Supervisors* are encouraged to provide a work environment that provides for discreet and sensitive *Investigations* while simultaneously minimizing chances of inadvertent or unnecessary exposure to *Contraband Images*.
- 9.3 ICAC *Equipment* shall be reserved for the exclusive use of its *Members*, and shall be used in accordance with these *Standards* and with their respective agency's policies.
- 9.4 When practicable, *Equipment* which may be used in undercover aspects of an *Investigation* shall be purchased covertly.
- 9.5 No personally-owned equipment, accounts or networks shall be used in *Investigations*.
- 9.6 Software shall be properly acquired and licensed.

10. Victim Identification

- 10.1 Identifying child victims of *Crime* is a critical element of the *ICAC Program. DOJ* and *OJJDP* require the *Lead* and *Affiliate Agencies* to submit *Contraband Images* to CVIP as a means to improve child victim identification. Absent exigent circumstances, *Contraband Images* shall be sent to CVIP pursuant to NCMEC's standards regarding same. In addition, *Lead* and *Affiliate Agencies* are encouraged to collaborate with NCMEC in their effort to identify children depicted in *Contraband Images*.
- 10.2 Absent exigent circumstances, victim-identifying information shall be protected from public disclosure pursuant to the protections set forth in federal and state law.
- 10.3 Lead and Affiliate Agencies shall adhere to local, state, and federal laws, as well as their agency's policies regarding mandated reporting, victim notification, and victim assistance.

11. Public Awareness and Community Outreach

- 11.1 Public awareness activities and community outreach are a critical component of the *ICAC Program. Lead* and *Affiliate Agencies* shall foster awareness and shall provide practical relevant guidance to children, parents, educators, and others concerned with child safety.
 - 11.1.1 Social media can be used to promote educational awareness as long as it is consistent with all agency policy and these *Standards*.
- 11.2 Presentations to school personnel, parents, and community groups are excellent ways to promote awareness. These presentations shall not include any visual depiction of a victim unless the victim has consented to its use and the victim is currently at least 18 years of age. No *Contraband Image* shall be used in these presentations nor shall a presenter discuss confidential *Investigative* tools and techniques.
- 11.3 No individual affiliated with *ICAC Program* may speak on behalf of the national *ICAC Program* without the express written consent of *OJJDP*. While making public presentations, *Members* may indicate a preference for a product or service, but, when done, shall avoid an implicit endorsement and shall include alternatives in the presentation.
- 11.4 Materials and presentations shall be consistent with the *ICAC Program's* mission and background, as enumerated in Section 2 of these *Standards*.

12. Media Relations and Media Releases

- 12.1 Media releases relating to prosecutions, *Crime* alerts, or other matters concerning ICAC operations shall not include information regarding confidential *Investigative* techniques, and shall be coordinated, when applicable, with the law enforcement agencies involved with the subject *Investigations*, in a manner consistent with sound information management and sound media relations practices.
- 12.2 *Commanders* and *Supervisors* may speak to members of the media about their own agency's ICAC-related activities per the terms of their agency's policy on such media relations. No individual affiliated with *ICAC Program* may speak on behalf of the national *ICAC Program* without the express written consent of *OJJDP*.
- 12.3 *Commanders* shall inform their *OJJDP* Program Manager if approached by national media outlets about the national *ICAC Program* (as opposed to media seeking information from a particular *Task Force* about its local activities) so that a coordinated national response can be prepared by *OJJDP*.
- 12.4 Information provided by *Task Forces* to the media shall be consistent with *ICAC Program's* mission and background, as described in Section 2 of these *Standards*.
